





### Care Was Redefined as Obedience

- The responsibilities that come with Freedom and Intelligence were abdicated to others through **compliance with authority**.

**“Good people” were those who obeyed.**







### Common Sense Replaced with Compliance

- Compassion once meant listening, discernment, and human presence.
- It became outsourcing care to impersonal institutions and approved messaging.
- “Common sense” was redefined as repeating what was authorized.
- Human complexity was flattened into policy, enforcement, and automation.

## Dissent Reframed as Violence

Questioning was labeled “harm”

- “Israel has a right to defend itself!”
- “Trust the vaccine experts or you’re hurting grandma!”
- “Trans kids matter!”
- “Erika Kirk is a grieving widow!”



# SECTION I — Divide & Conquer

## Separation Was Framed as Virtue

- Isolation was framed as a means to find love
- Distance was framed as duty
- Real Community (off grid food and shelter and community economics) was treated as a threat




## SECTION II — The Political Relevance

### Law Enforcement as “Moral”

- Policing shifted from protecting rights to enforcing ideology
- Non-violent citizens are treated as violent criminals
- “Just Comply!”

### Emergency Powers Override Conscience

- Crisis language justified suspension of ethical norms
- Then emergency became permanent
- Personal conscience was subordinated to decree



## SECTION III — Shadow Work

### The Fear of Death

- **Life is not reducible to the body**

### Fear of Death Used to Suspend Ethics

- Fear of death replaced proportional reasoning
- Fear justified coercion
- Fear short-circuited moral restraint

### Fear of Death – To Create Mass Psychosis



*Mass psychosis causes moral and spiritual decline, making individuals irrational, emotional, erratic, and unreliable. They commit crimes unthinkable individually. Those afflicted are often unaware of their condition, much like an individual's inability to observe their own madness.*

*Psychosis results from a detachment from reality, leading to delusions—false beliefs considered true despite evidence to the contrary. Delusions vary, from paranoia to grandiosity, influencing individuals' behaviour.*

## SECTION IV — COVID


### Absurdities and Inconsistencies

- The vaccine being alleged to be 100% effective by both Pfizer and the mainstream media.
